Justice Involvement

- ☐ Currently involved in or previous involvement with the Juvenile or Adult Criminal Justice System
 - □ Current or previous incarceration
 - Under Alternative Sentencing by the criminal justice system
 - Under a Diversion Program as an alternative to prosecution
 - Under the supervision of the Criminal System
 - Out-of-home placements
 - On probation or on parole
